The details of the seats remaining vacant after CAP Round-III will be published on the website of the institute by **09.09.2024** by **10.00pm**. The vacancy position may dynamically change on every day of the counselling round.

#### Instructions:

- 1. Only the candidates registered online through CET portal and verified their application before cutoff date, are eligible. New applications will not be considered.
- 2. These admissions will be made strictly in the order of inter-se merit amongst the candidates who have applied through in the form available on the college website for counselling round at <a href="https://forms.gle/XV7xJKmTcHJxFAVu9">https://forms.gle/XV7xJKmTcHJxFAVu9</a> this link and report in person for the counselling rounds on the date given above.
- 3. The candidate will need to pay an online registration / application processing fee of Rs. 1000/for all category students.
- 4. The candidate will lose the claim to participate in the admission counselling process if he/she fails to produce all the applicable original documents at the time of document verification during the Counselling round. In case a candidate has taken admitted elsewhere, he/she will be required to produce the original fees receipt, the Original Admission Confirmation Letter of that institute and submit one self-attested photocopy of each document.
- 5. After successfully verifying the relevant original document, further eligible candidates will be called for seat allotment by counselling according to inter-se merit.
- 6. At the time of seat allotment by counselling, the candidate is required to submit "Requisition for Seat Allotment."
- 7. The seat allotment will be carried out based on the vacancy status at the time of candidates reporting to the counselling round (as per the reference Rule No. 13 mentioned in the Information Brochure for the academic year 2024-25 published by State Common Entrance Test Cell, Maharashtra State). Accordingly, the seat allotted to a candidate would then be deleted from the pool of vacant seats displayed on the auditorium screen. Candidates are advised to be present in the Counselling Hall and wait for their turn as per inter-se merit. If a candidate is not available when called, the next candidate on the merit list will be called for allotment of seat and the absent candidate may miss his/her chance of merit-based seat allotment.
- 8. However, if a candidate of higher merit reports late during the process of counselling, and seeks admission against seats vacant (of a particular category to which he/she belongs) at the time of reporting, would get a preference for admission over the candidates with lower rank present at that point of time. The decision of the admission center coordinator shall be final and binding in this regard.
- Confirmation of the allotted seat to the candidate is subject to the submission of the requisite Institute admission fees. The candidate is required to pay fees through online on web portal <a href="https://nitkop.in">https://nitkop.in</a>, or Demand Draft in favour of Principal, "The Director, New Institute of Technology, Kolhapur" payable at Kolhapur.

### Note:-

- 1. The reserved category students eligible to apply for scholarship will have to apply to MahaDBT portal of Government of Maharashtra to avail the scholarship benefit. If the students do not applyto this portal for scholarship/if the scholarship benefit is denied to any student by the competent authority for any reason, whatsoever, the student will have to pay the full fee as applicable to the open Category Students.
- 2. Government Resolutions published from time to time in this regard, will be applicable and bound to all the students.
- 3. If a candidate fails to pay the requisite institute admission fees at the time of seat allotment, then his/her seat allotment will be cancelled and the seat will be allotted to the next candidate on the merit list. Part Payment or Payment through cash/cheque will not be accepted under any circumstances.
- **4.** Candidates already admitted to SPCE in CAP Rounds, in the F. Y. B. Tech. Programme for AY2024-25, who are aspiring for branch change should also remain present in person and furnish the original admission confirmation letter issued by SPCE.
- **5.** Mere participation in the Counselling Round and paying the registration fees doesn't guarantee the confirmation of admission in the Institute.
- 6. The candidate shall not be entitled to any refund of his/her fees if the online cancellation if effected by the candidate after 5.00 pm of the cut-off date prescribed by the Competent Authority i.e., 13<sup>th</sup> September 2024.
